The University sent admissions decisions in December (Early Action round) and at the end of March (Regular Decision round).

Every April, it is time to welcome newly admitted students to the local Princeton community. In April 2023, the Alumni Schools Committee, Parents Committee, and the Princeton Club of Chicago hosted alumni, admitted students, and their families at an in-person reception for newly admitted students.

Asian American Alumni Association of Princeton (A4P) Yeri Lee '15 S13

The Asian American Alumni Association of Princeton (A4P) continues to develop programming supporting Princeton students and alumni in advancing Asian American and Asian interests and issues. The Year of the Tiger was a special year for the A4P and Princeton communities. In-person gatherings for Lunar New Year, Reunions, and Diwali returned in 2022, and students and alumni explored Asian cuisine in the Princeton area together. Virtual events promoted civic engagement, with topics such as disinformation and democracy, and bystander intervention training. The Recent Alumni Committee organized a panel discussion featuring accomplished alumni in law, medicine, tech, and journalism, and a conversation around the Great Resignation and alumni stories on career changes. Association of Black Princeton Alumni (ABPA) Nat Piggee '96

The mission of ABPA is to strengthen the relationships among Black Princeton Alumni and with the broader Princeton University Community by providing content, access to resources, and opportunities that allow for deeper connection and engagement. This year, our primary activity was co-sponsoring Princeton Diversity Discussions in Chicago and elsewhere.

Association of Latino Princeton Alumni (ALPA) Jessica Gonzalez '95

This past year, ALPA has been working on strengthening ALPA's regional presence around the country. Regional event planning has been one of ALPA's key initiatives, to help build community and create and sustain impactful connections among ALPA members and with members of the broader Princeton community. In addition to reaching out to individual ALPA members who have an interest in planning events in their communities, ALPA has been actively engaged in collaborating with Princeton regional associations and other affinity groups. While events in Chicago recently have been limited, ALPA hopes to change that in 2023 and looks forward to collaborating with the PCC on future events!

ALPA's Race and Equity Committee continues to lead on promoting racial and gender equity and inclusion in the broader Princeton University community by continuing to host the Princeton Diversity Discussions. The Committee also engages and inspires people to pursue racial equity and social justice by organizing conversations on topics of interest to the Latina/o/x/e community. It recently hosted a well-attended book discussion on <u>Racial Innocence: Unmasking Latino Anti-Black Bias and the Struggle for Equality</u>, by Tanya Katerí Hernández, a revelatory work on the existence, persistence, and continuing harmful impact of anti-black bias in the Latina/o/x/e community.

During Reunions last year, ALPA sponsored several events on campus: a Lifetime Tiger wine tasting; the annual member reception at Chancellor Green; a musical performance by the Texas-based artist El Dusty; a *Cafecito* gathering for alumni and students; and a digital storytelling "pop-up" studio organized by ALPA's "Recuerdos" team to record 12 alumni interviews. ALPA was also pleased to help finance the return of young Latina/o/x/e alumni with limited resources to campus for Reunions and hopes to do the same in the future.

Career Networking Committee Anna Huang '07 and Robert J. Khoury '90

The Princeton Club of Chicago Career Networking Committee hosts discussions and informal networking events around specific industries and career topics. Given the (continued) unique circumstances of our time, we organize a variety of hybrid speaker events and networking sessions in the spirit of openness, sharing, and contribution.

We held our 12th annual summer internship luncheon for current Princeton students, alumni, and parents as our first hybrid in-person and virtual event. Attendees shared their backgrounds and what they hoped to get out of the event, e.g., job opportunities and opportunity to mentor students. At least one student has confirmed a successful internship placement to date, thanks to this event! Thank you to Al Chan '91, who generously provided each student with a copy of Robert J. Khoury's '90 book: *How to Intern Successfully: Insights & Actions to Optimize Your Experience*.

We hosted the Summer City Connections Chicago: Student Panel & Networking Reception last June. Given its success, we plan to partner again with Princeton's Center for Career Development, Princeton Internships in Civic Service, and PCC's Young Alumni Committee to host a similar event this summer. We will open this event to all students, interns, and alumni of any stage in their career who are in Chicago this summer to create more in-person opportunities. Distinguished Service Awards Committee

Marquis Parker '99 S02 and Haley White '12

Once again, your Awards Committee takes great pleasure in naming two outstanding honorees. We would also like to thank this year's Committee members for their kind and thoughtful assistance.

Jenny Korn '96, John Fish '55 Distinguished Service to the Community Award

Jenny is a feminist activist of color for social justice and scholar of race and gender in mass media and online communication. Her home base is the University of Illinois at Chicago, but she is also the founding coordinator of the Race+Tech+Media Working Group at Berkman Klein Center for Internet & Society at Harvard University. An award-winning author with numerous publications, she has given 100+ talks at invited keynote presentations, university guest lectures, interactive community education, and refereed conference presentations.

Jenny's academic work focuses on diversity, and her service activities for both Princeton alumni and the community at large are similarly targeted. She has touched multiple communities, offered insights, and established several forums to explore diversity, but her most notable community service activity has been the Princeton Diversity Discussions series of events. Originally launched in 2014 as monthly inperson events here in Chicago with only Princeton alumni participants, it provides a place for people from a range of backgrounds, ideologies, political leanings, etc. to come together and engage in open discussion about often dicey issues, like race, gender, sexual orientation, laws, and public policy. Over the past nine years, Princeton Diversity Discussions has expanded to include both Princetonians and non-Princetonians and has engaged with thousands of people around the world through virtual events organized through 40+ clubs, associations, and classes related to Princeton and 10+ organizations related to Harvard. Through this work, Jenny has impacted hearts and minds, and, more importantly, has shown that diversity is a concept that all people need to understand, explore, and promote.

Stephen Ban '84 S88 P23, Arnold M. Berlin '46 Distinguished Service to Princeton Award

Stephen is the Founder of Green Cat Advisors, LLC, where he consults to mission-driven organizations with a focus on ESG and the greater good. Prior to that, he had a distinguished business career focused on Marketing and Communications leadership across several industries, including Financial Services and Professional Services.

He has worked tirelessly for Princeton since he graduated in 1984. His work includes serving as a Class of 1984 officer since 1994, co-chairing two reunions (10th and 15th), working on four reunion committees, serving as '84 webmaster, serving as '84 PAW Secretary for the past 14 years, and serving as '84 Vice President (2004-2019) and President (2009-2014). At the local level, he was a Princeton Club of Chicago board member during the 1980s, 1990s, 2000s, 2010s, and now 2020s. He served on the Committee to Nominate Alumni Trustees from 2012 to 2015, where he met regularly on campus and traveled around the U.S. to interview potential candidates. Stephen absolutely bleeds orange and black, and he has never hesitated to give his time to Princeton as a way to reciprocate for all that it has done for him.

In addition to his Princeton-related efforts, he further serves communities that he cares about as a Senior Advisor for the Corporate Coalition of Chicago to reduce economic inequities and catalyze economic development on Chicago's South and West sides, as an Adjunct Professor for Loyola University Chicago's Quinlan School of Business, and as a Level 4 Referee for USA Hockey.

Diversity Discussions Jessica Gonzalez '95

Princeton Diversity Discussions was founded in the Chicago area. For nearly a decade, Jenny Korn '96, founding director, and Jessica Gonzalez '95, director for Illinois/Chicago, have continued to lead monthly discussions for our region. Having gone virtual in Spring 2020, a Princeton Diversity Discussion now occurs somewhere in the US on an almost weekly basis. This ongoing series of friendly and inclusive gatherings for discussing race-related issues is supported by numerous regional alumni organizations and alumni affinity groups, including the Princeton Club of Chicago. Princeton Diversity Discussions has teamed up with the Duke Black Alumni Association, Harvard Women in Design, and Harvard Kennedy School's Women's Network to co-host discussions, and we are open to additional organizational collaborations. Our Illinois/Chicago discussions are routinely attended by dozens of alumni each month, and our discussions this year have ranged from conversations about representation on the US Supreme Court, latest challenges to civil and voting rights, and responses to racially charged incidents, to discussions of diversity in books, music, movies, and television. The mission of the Princeton Club of Chicago's Parents Committee is to provide a friendly welcome to newly admitted students and their parents or guardians, answer questions about the move to college, assist with our New Admits Reception in April, and host our Annual Summer Picnic at the end of July. Princeton in Chicago Schools (PICS) Scholarship Bob Loveman '69, Charlene Huang Olson '88 P19 P21, and Bruce Rosenberg '69 Since 1990, the Princeton Club of Chicago has had a partnership with Roosevelt High School in the Albany Park neighborhood of Chicago. After awarding aid-based college scholarships to high-achieving Roosevelt seniors for ten years, with the last new scholarships presented in 2019, this year we continued to honor previously awarded scholarship commitments by supporting two PICS Scholars studying at these institutions: DePaul University and University of Wisconsin. Since the first scholarships were presented in 2010, our PICS program has awarded \$144,000 in financial aid, helping to make a four-year college education accessible for 46 Roosevelt graduates. We did not host any in-person events with the PICS scholars this academic year, but we hope to reunite all scholars this summer to celebrate the graduation of our final PICS scholars.

Princeton Internships in Civic Service (PICS) Yung Bong Lim '87 P23 P25 and Bob Loveman '69

The Princeton Internships in Civic Service (PICS) program was started by the Class of 1969 to provide paid summer internships in the non-profit sector to Princeton students. Since 1996, around 2,000 internships have been sponsored by PICS in multiple states and countries. The program is now officially part of the University, under the Pace Center for Civic Engagement. In 2022, 11 Chicago-area organizations hosted 13 internships. Members of the Princeton Club of Chicago sourced, funded, and served as Alumni Mentors for some of these internships. Also, the PCC PICS Endowment Fund, which was established in 2021, helped provide stipends for some of these internships. Princeton Prize in Race Relations

Princeton continues to be a leader in its financial aid policies. Every student admitted can attend Princeton, regardless of their family's economic circumstances. Approximately 62% of the undergraduate student body - more than 3,400 students - received financial assistance in 2022-23. As a result, 83% of Princeton students graduate debt free.
