Once again, we conducted 100% of our interviews virtually. We did not represent Princeton at any college fairs or high schools this year, but we look forward to resuming those activities when it is safe to do so.

The University sent admissions decisions in December (Early Action round) and at the end of March (Regular Decision round).

Every April, it is time to welcome newly admitted students to the local Princeton community. In April 2022, for the first time since 2019, the Alumni Schools Committee, Parents Committee, and the Princeton Club of Chicago hosted alumni, admitted students, and their families at an in-person reception for newly admitted students.

Asian American Alumni Association of Princeton (A4P)

Since its inception in 1979, the Asian American Alumni Association of Princeton (A4P) has supported Princeton students and alumni in advancing Asian American and Asian issues in student life, University affairs, and post-graduate careers. A4P was instrumental in advocating for the Princeton Asian American Studies certificate program, which was created in 2018. In 2021, A4P hosted virtual gatherings for Lunar New Year, Reunions, and Diwali. The mission of ABPA is to strengthen the relationships among Black Princeton alumni and with the broader Princeton University community, by providing content, access to resources, and opportunities

that allow for deeper connection and engagement. As part of our 50th year celebration, ABPA engaged in listening sessions to get input from membership on our future.

Association of Latino Princeton Alumni (ALPA)

Over the last year, ALPA's primary activities have continued to be virtual, with a few regions being able to host in person events (let's work on this for next year, Chicago!). ALPA's biggest push this year has been work on The Recuerdos Project, which focuses on creating an archive of documents from which to build a history of Latina/o/x/e experiences at Princeton. The focus of the project is wide-ranging and includes: document research and the creation of a timeline of Latinx history at Princeton; hosting writing workshops that help alumni begin the process of recalling their experiences and writing about them; soliciting testimonios in various forms, including prose, poetry, artistic works, and recorded oral interviews; and hosting virtual gatherings that bring together alumni from specific decades so they can recall their experiences together and rebuild community. In addition, ALPA's Race and Equity Committee continues to lead in: creating statements and policies in support of racial and gender equity and inclusion; working in collaboration and support of other affinity organizations; and designing and executing events that relate to race and equity. Cafecito Second Sundays, which are intended to create community among alumni and current students and are organized by a different theme or topic each month, has become a wonderful way for alumni and current students to connect, network, and learn.

Other notable events include the Reunions Community Pachanga, support and welcoming new Latinx graduates at the Fields Center after graduation, co-hosting a session with ABPA on "Preparing for the Corporate Board: Why Diversity Matter", hosting a panel on "What Do We Call Ourselves and Why? A Multigenerational Panel on Community Labels", and leading a book discussion on Latinx Heritage with Author Dr. G. Cristina Mora *09, fall 2021, as well as celebrating the holidays with Las Posadas and a virtual ALPA holiday party. We hope and encourage local Chicago alumni to attend ALPA's virtual offerings, and let's gather in person soon!

Career Networking Committee

The Princeton Club of Chicago Career Networking Committee hosts discussions and informal networking events around specific industries and career topics. Given the (continued) unique circumstances of our time, we organized a variety of virtual speaker events and networking sessions to encourage participation.

We held our 11th annual summer internship "luncheon" for current Princeton students, alumni, and parents via Zoom. All attendees shared their background and what they hoped to get out of the event, e.g., job opportunities and opportunity to mentor students, both in large group and smaller group breakout sessions. Thanks to the generosity of Al Chan '91 and Marquis Parker '99 S02, all students received a copy of Robert J. Khoury's '90 book "How to Intern Successfully". We also held an optional follow up session to support students with their progress in late January.

The spirit of all these events is openness, sharing, and contribution. Events are well attended, with 20-40 alumni and students. Past networking events included topics on academia, non-profits, finance, technology, and entrepreneurship.

Paige Ponder '96, John Fish '55 Distinguished Service to the Community Award

Paige is Senior Advisor at One Million Degrees, an organization dedicated to helping low-income community college students succeed in school, work, and life. From 2012-2021 she served as CEO of this, the only organization in Illinois that provides wrap-around supports to highly motivated community college students to help them succeed in school, work, and life. Prior to joining One Million Degrees, Paige led Project Exploration, a dynamic youth STEM organization. She previously served as Officer of Student Support and Engagement at Chicago Public Schools, where she designed and led initiatives to drive up the number of freshmen who were on track to graduate, by developing early warning indicators and disseminating best practices to better support freshmen during their "make or break" year.

Paige also has experience in for-profit education, having worked for The Grow Network and McGraw-Hill in product development, professional development, and client services capacities. She began her career as a Princeton Project 55 Fellow at Holy Cross Elementary School in the South Bronx, NY, where she rose to become Assistant Principal. Paige was appointed to the Illinois Community College Board in 2018; she currently serves on the Steering Committee for the Consortium for Chicago School Research at the University of Chicago and is a 2019 Leadership Greater Chicago Fellow. For her sustained commitment to education and her dedication to assisting in the upward mobility of under-resourced families in the Chicago community, we are delighted to present her with the John Fish '55 Distinguished Service to the Community Award.

In addition to her years of service to Princeton in a variety of other capacities, Amy for six years served as a senior officer of the Princeton Club of Chicago: two years each as Secretary, Vice President, and President. For nearly a decade, Jenny Korn '96, founding director, and Jessica Gonzalez '95, director for Illinois/Chicago, continue to lead monthly Princeton Diversity Discussions for our region. Having gone virtual in Spring 2020, a Princeton Diversity Discussion now occurs somewhere throughout the US on an almost weekly basis. In his 2021 State of the University letter, Princeton University's President Christopher L. Eisgruber remarked, "We will press onward with the actions and conversations required to make this University stronger, more inclusive and equitable, and truer to the aspirations that we cherish. Doing so will require more discussions about challenging topics, including race in America and at Princeton." Princeton Diversity Discussions is our ongoing series of friendly and inclusive gatherings for discussing race-related issues, supported by numerous regional alumni organizations and alumni affinity groups, including the Princeton Club of Chicago. Princeton Diversity Discussion have teamed up with the Duke Black Alumni Association, Harvard Women in Design, and Harvard Kennedy School's Women's Network to co-host discussions, and we are open to additional organizational collaborations. Our Illinois/Chicago discussions are routinely attended by dozens of alumni each month, and our discussions this year have ranged from conversations about representation on the US Supreme Court, latest challenges to civil rights, and responses to racially charged protests, to discussions of diversity in books, music, movies, and television. He began his career as an Assistant Professor at Northwestern University, after which he worked at Bell Labs (originally part of AT&T, then Lucent Technologies, Alcatel-Lucent, and Nokia) managing research and development of highly fault-tolerant telecommunication infrastructure. He is now retired. As a long-time board member and former president of the India Classical Music Society, he has helped promote awareness and appreciation of Indian classical music. While he did a good bit of sailing on Lake Michigan in his younger days, he now enjoys more relaxed activities such as bridge, travel, and reading. He lives with his wife, Shalini, in Naperville.

- **Dani Houchin '90**

Dani Houchin '90 graduated Princeton with a degree in Public and International Affairs. The mission of the Princeton Club of Chicago's Parents Committee is to provide a friendly welcome to newly admitted students and their parents or guardians, answer questions about the move to college, assist with our New Admits Reception in April, and host our Annual Summer Picnic in August. Princeton in Chicago Schools (PICS) Scholarship

Since 1990, the Princeton Club of Chicago has had a partnership with Roosevelt High School in the Albany Park neighborhood of Chicago. Tutoring in the classroom was not possible during FY22 due to the pandemic.

After awarding aid-based college scholarships to high-achieving Roosevelt seniors for ten years with the last new scholarships presented in 2019, this year we continued to honor previously awarded scholarship commitments by supporting five PICS Scholars studying at these institutions: DePaul University, Loyola University, UIC, and University of Wisconsin.

Since the first scholarships were presented in 2010, our PICS program has awarded \$144,000 in financial aid, helping to make a four-year college education accessible for 46 Roosevelt graduates.

Committee members, mentors, and students usually gather one to two times a year over dinner to connect and foster relationships. As the majority of PCC events continued to be remote this year, we did not host any in person events with the PICS scholars. We hope to schedule one when conditions permit. Mentors and scholars are encouraged to engage with each other throughout the year.

Princeton Internships in Civic Service (PICS)

The Princeton Internships in Civic Service (PICS) program was started by the Class of 1969 to provide paid summer internships in the non-profit sector to Princeton students. Since 1996, over 1,600 internships have been sponsored by PICS in multiple states and countries. The program is now officially part of the University, under the Pace Center for Civic Engagement. In 2021, eight Chicago-area organizations hosted nine internships. Members of the Princeton Club of Chicago individually sourced, funded, and served as Alumni Mentors for some of these internships. Also, a small group of leaders of the Club raised over \$150,000 to establish the PCC PICS Endowment Fund, which will help provide stipends for future Chicagoland internships. Princeton Prize in Race Relations

This year, the Chicago Committee of the Princeton Prize in Race Relations received 15 wonderful applications from high school students who, despite the continuing challenges of the pandemic, engaged in powerful racial equity and race relations work in their communities. Our 17-person committee of alums promoted the program and encouraged applicants from throughout the region,

reviewed applications, and collectively chose our winners. After an engaging discussion, we awarded our 2022 Prize to Kashyap Rajesh, a sophomore at Adlai E. Stevenson High School and Global Chapter Director at Encode Justice, an international youth-led coalition fighting for human/civil rights, and justice under Artificial Intelligence for minorities. We also awarded Certificates of Recognition to Janet Amuh and Justen Pippens (both Homewood Flossmoor High School), Feker Chane (Northside College Prep), and Jalyn Marshall (Goode STEM Academy) for their powerful work on equity and race relations. The Chicago Region Awards ceremony was held virtually on April 18 with distinguished keynote speaker Congressman Raja Krishnamoorthi '95.

It is an important part of Princeton's financial aid effort and continues to set a sterling example in assisting undergraduates with funding the cost of an outstanding education.

Princeton continues to be a leader in its financial aid policies. Every student admitted can attend Princeton, regardless of their family's economic circumstances. Approximately 61% of the undergraduate student body, more than 3200 students, are receiving financial assistance in 2021-22. As a result, 83% of Princeton students graduate debt free.
